      - The above shows don't have a lot for kids to do, however we would like to do a kids/Junior show in the late winter/spring.
        - Kids show suggestions:
          - Pirates of Penzance
          - Alice in Wonderland
          - Aladdin Jr
          - Fruitcakes
          - Willy Wonka

- It was noted that the goal for the kids show is to provide onstage opportunities including younger performers, as well as to draw more audiences. We are also still considering how to pair adults and younger people so that young people have staff roles.
- Today the board will take input and opinions and factor them into a decision.
- Input from Sarah as the chosen director:
  - o She wants to have the input of the membership.
  - o She is leaning toward Once Upon a Mattress for a number of reasons.
  - Pajama Game or one of the repeat shows (Fiddler, Music Man) are not her first choice - but she is willing to consider these.
- There was discussion about making show decisions to meet a balance between making money and other factors (e.g. artistic, community involvement).

### 5) President's Remarks

- Pam Crary gave heartfelt thank you to departing board members Dan Subach and Dana Stein for all of their work over the past years. Also, thank you to all who have included our new members and reached out to them and made them feel included and accepted.
- Pam is interested in education and improvement: how as a group can we do things better? She wants to constantly assess and find ways to improve.
- Pam discussed interests for next year:
  - Get business cards
  - Institute a scholarship committee to offer opportunities to students and adults, controlled by the board
  - o Provide a detailed orientation to the school for the board- genie, alarms, safety process in place, numbers to call.
