Old Business

Pick 2009 shows: Summer 2009:

Spring 2009:

- Chris proposed Charlotte's Web, staffed with adults with kids learning the staff roles. April timeframe, Chris as director
- Note: Oregon spring break is April 6-10

• We also have Alice in Wonderland as a potential choice, based on the result of the work that was done by the kids' group.

Discussion:

1)The feedback from the group of kids was valuable to the board. The main points we think we heard from the kids' group were that:

- They want lots of good sized roles
- They want kids to get the opportunity to learn staff positions
- There is some interest in non-musicals
- They think that familiarity with a show is important to get people to be in it and to come.

2) There was discussion about the fact that not all the kids may have been in agreement that Alice in Wonderland was what they wanted to do, and how we can improve this process in the future so that there is consensus and all involved understand their obligation to speak up.

3) There was discussion about the fact that doing a non-musical makes it easier to have kids on staff – less complicated, don't need a music director. Also less overall rehearsal time, likely easier to schedule. Nice to give kids who may not sing as well the chance to do a play.

Decision:

There was a motion and a second to do Charlotte's Web with Chris as director, David as a mentor, no other staff yet determined. Dates are to be determined (likely at end of March or in April). Motion was approved.
